While reviewing the data produced through online payment gateway system, it was observed that the districts KKR, Mewat, Panchkula, Rohtak & Sonepat have less achievement in case of number of beneficiaries uploaded for disbursement of subsidies. The matter was taken seriously by MD & instructed to increase the no. of beneficiaries in order to cover more & more beneficiaries under MIDH.

During review of Action taken report, the following decisions were taken:

3.1 Under Small Nursery (Private) component, targets has been given to Districts Hisar & Sonepat. MD instructed to MS, DHMIU Hisar to submit the case under Small Nursery (Private) component within 7 days & MS, DHMIU Sonepat to sensitize beneficiary to complete project at the earliest, so that targets could be achieved in time.

(Action taken by: MS, DHMIU Hisar & Sonepat)

3.2 MD directed all MS, DHMIUs to depute all DHCs to achieve the target of Vending Card within 30 days. MD instructed all MS, DHMIUs to surrender target if unable to achieve targets in time.

(Action taken by: All MS, DHMIUs)

3.3 MD directed all MS, DHMIUs to depute all DHCs/Supervisors for inspection of vegetable cases in open fields.

(Action taken by: All MS, DHMIUs)

3.4 Under Protected Structure component, State Govt. has released 15% extra state share. Therefore, MD instructed all MS, DHMIUs to send report of accurate beneficiary list to HQ along with inspection report of DMC.

(Action taken by: All MS, DHMIUs, PSE-I & SO)

3.5 After discussion it was decided in house that under component of Hybrid vegetables the cut of date for all vegetables except onion is 25th October 2016. This date should be complied strictly.

(Action taken by: All MS, DHMIUs & HC-I)

Agenda No. 4: Review of progress of SCSP component under MIDH scheme up to September, 2016.

The report under SCSP has been received from all districts. After compilation it will be put up on file for information of authorities. MD instructed SO to submit report under SCSP component in prescribed performa after taking report from districts. This report must be compiled on or before 5th of every month. All MS, DHMIUs are directed to submit this report directly to SO (somidhharyana@gmail.com).

SCSP report for 2015-16 is pending from districts Jhajjar, Jind, Kurukshetra, Palwal & Panchkula. MD instructed to submit report within 3 days.

Agenda No. 5: Brief Power-point Presentation on protected structure by DHCs.

It was decided in the meeting that the photographs taken by them during their field visits should have the picture of beneficiary along with DHCs in farmers field having date of visit. In case of protected structures, the photograph should contain crops in background. These photographs should be compiled in CD and this CD should be submitted to PSE-II in next meeting.

(Action by: All MS, DHMIUs, DHCs & PSE-II)

Agenda No. 6: Review of Progress of Centre of Excellence.

- a) CSTF, Ladwa: DDH, CSTF informed that DGH has instructed for estimation of condemn building from PWD, B & R and submit complete proposal for dismantling of old building. MD instructed DDH, IBDC for compliance of instructions given by DGH.
- b) IBDC, Ramnagar: DDH, IBDC informed that
 - i. Saw machine will be installed within one week.
 - ii. The flooring work has been completed.
 - iii. Electrification work has been completed.
 - iv. Civil work is under progress.
 - v. The mobile towers installed needs to be shifted. MD instructed C/IT for execution of this work within 15 days positively.

MD instructed DDH/IBDC for preparation of list of components/activities, which are lagging behind or are not started yet, so that prompt action could be taken up. Further, the list of machinery and equipments should be prepared for purchase after due process.

- c) COE for Horticulture, Sunderah: DHO Narnaul informed that
 - An amount of Rs. 108.50 lacs has been transferred to HSAMB for construction work.
 - Regarding uprooting of plants in construction area a letter has been written to Forest Department. NOC is awaited from Forest Department.
 - A letter has been written to PWD, B & R for installation of Tube well.
- d) COE for Horticulture, Hodal: An estimation need to be prepared for construction work at this centre. MD instructed JE/Civil to visit Hodal and submit report within 7 days.
- e) COE for Horticulture, Sondhi: The progress of this centre was slow. MD instructed DHO Jhajjar to expedite the work as a State Level function has to be organized at this centre.

f) New COE for Horticulture: MD informed all MS, DHMIUs to identify the land in districts where Centre of Excellence for Horticulture has not been established.

(Action by: DDH/IBDC, DDH/CSTF, MS, DHMIU Palwal, Narnaul & Jhajjar)

Agenda No. 7: Any other item with the permission of Chair.

- 7.1 It was decided in house that a team comprising MS, DHMIU, DHC & supervisor should ensure the quality of garlic seed to be supplied before supplying the seed.
- 7.2 MD instructed all MS, DHMIUs, to be vigilant while recommending cases for online payment on Hortnet payment gateway. It becomes their personal liability if any payment is made wrongly. He further advised not to disclose their password to any other person even in their subordinate staff.
