During review of meeting, the following decisions were taken:

3.1 During the meeting, it was decided in the House that in cases of hybrid vegetables, the physical verification of 5 acre area should be verified by concerned MS, DHMIU in person, all the cases more than 4 acre and below 5 acre area should be verified by concerned DHCs. The cases below 4 acre area should be physically verified by Horticulture Supervisors. A certificate to this effect should be submitted by concerned MS, DHMIU at HQ that the cases under hybrid vegetable component have been verified in the district and there is no pendency for want of physical verification.

3.2 MD directed HC-I to visit District Mewat immediately for inspection of cases of hybrid vegetables.

3.3 All MS, DHMIUs were directed to achieve 100% targets under the component Rejuvenation upto 31.12.2016.

3.4 It was informed in the House that new projects under component Integrated Post-Harvest Management can be accepted by MS, DHMIUs despite of not having any targets. MD informed that as Govt. of India is focusing more on this component. So, new projects may be considered & sent to HQ accordingly.

3.5 Under component of Horticulture Mechanization, as the achievement is very less it was decided in the house that MS, DHMIUs will consider the fresh cases under this component as per physical and financial targets approved under MIDH AAP 2016-17.
