The meeting was started by welcoming all the members and the agenda was discussed and actions taken are as under:

# Agenda No. 1: Confirmation of the proceedings of 41st MIDH meeting.

The minutes of 41<sup>st</sup> MIDH meeting which was held on dated 14.09.2018 were circulated vide memo no. 4145-66/Hort-APO/NHM/5/XI/IV dated 20.09.2018 to all concerned. As no comments were received from any quarter, so the minutes of 41<sup>st</sup> meeting were confirmed.

#### Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 5135.75 lakhs out of total approved outlay of Rs. 20988.65 lakhs which is approx. 24.5% achievement. MD has taken the matter seriously as about six months of the year is going to be completed & directed all the field functionaries to expedite the progress to achieve 60% of the targets year marked upto October, 2018. Following decisions were taken during the review:

Some MS, DHMIUs informed that the quality of the supplied seed is very good.
 MD instructed MS, DHMIUs to achieve the targets of Garlic seed till 30.10.2018.
 No cases of Garlic seed should be considered for release of assistance thereafter.

The achievements under project based activities like Cold store are very low. MD instructed to expedite the progress.

3. As a full fledge centre on Bee-keeping is operational, it was directed that the bee-boxes should be procured from IBDC & supply to farmers urgently.

The district-wise financial achievement was reviewed. It was very low. MD took the matter seriously & instructed all MS, DHMIUs to achieve the targets. The achievement of MS, DHMIU Ambala, Charkhi Dadri, Gurugram, Karnal, Mewat, Narnaul, Panchkula, Panipat, Rohtak, Sonipat & Yamunanagar was less than 20%. MD instructed EO to call explanation of these districts & submit the case for further necessary action.

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2018-19.

The report of additional assistance of 15% as State Share for protected structures is being submitted regularly by MS, DHMIUs to PSE-I. The funds from State Govt. for addition 15% assistance for the year 2018-19 are not released so far. The farmers are approaching & pressurizing MS, DHMIUs for release of additional 15% assistance. MD instructed SAO to follow the matter to release 15% assistance from State govt.
