MINUTES OF 31<sup>st</sup> MIDH MEETING HELD ON DATED 10.11.2017 AT 09:30 AM AT IBDC RAMNAGAR, KURUKSHETRA UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members and the agenda was discussed and actions taken are as under:-

### Agenda No. 1: Confirmation of the proceedings of 30<sup>th</sup> MIDH meeting.

The minutes of 30<sup>th</sup> MIDH meeting which was held on dated 04.10.2017 were circulated vide memo no. 3920-40/Hort-APO/NHM/5/XI/III dated 10.10.2017. As no comments were received from any quarter, so the minutes of 30<sup>th</sup> meeting were confirmed.

### Agenda No. 2: Action Taken Report of previous meetings.

The action taken report on the decisions taken in the previous meetings of MIDH was reviewed in detail and the following decisions were taken:-

Agenda No. 3: Component-wise review of progress made under MIDH scheme for the month of October, 2017.

The component-wise Physical & Financial expenditure was reviewed by Mission Director. It was informed that Govt. of India has approved Annual Action Plan for an amount of Rs. 109.29 crore (including Rs. 6.23 crore for committed liabilities) during 2017-18 under MIDH. The opening balance as on 01.04.2017 was Rs. 8.22 crore. The 1<sup>st</sup> instalment of Rs. 50.00 crore was released by Govt. Further, State Govt. has also released Rs. 6.95 crore as 15% Extra State Share for polyhouses. The total funds available under MIDH are Rs. 65.17 crores out of which 40.13 crore has been utilized. The balance funds as on 09.11.2017 available with HSHDA are Rs. 25.04 crore. Following decisions were taken during review of components:

3.1 The achievement under the component of Plastic crates is 45% which is very low. MD instructed all MS, DHMIUs to expedite the progress under this component to achieve 100% targets.

3.2 MS, DHMIU, Panipat has requested for additional 6 vending carts and MS, DHMIU, Karnal has requested for additional 10 vending carts. MD accepted

the request and additional vending carts were approved. MD also instructed other districts to achieve the targets as per their AAP.

3.3 During discussion reg. promotion of protected cultivation in Haryana state, it was decided by the House that the certificate of training of beneficiaries reg. protected cultivation and nematode reports of the field are compulsory documents in order to accord consent. In districts where the targets under this component have been achieved, a notice should be displayed on notice board in order to avoid any inconvenience to the farmers.

(Action taken by: PSE-I & All MS, DHMIUs)

3.4.It was decided in House that the training certificate is mandatory for release of assistance under the component of rejuvenation so that the concerned farmers could be benefited with the advance techniques of rejuvenation. MD instructed DDH, CSTF, Ladwa to organize training on rejuvenation and canopy management at CSTF, Ladwa immediately in first week of December.

(Action taken by: DDH, CSTF, Ladwa & All MS, DHMIUs)

3.5 There is need to develop post-harvest and marketing infrastructure in the state to reduce the post-harvest losses in the fruit and vegetables. Govt. of India has already reserved the 30-35% funds of total AAP. All MS, DHMIUs requested for one day workshop on "Strengthening of Post-harvest and Marketing Infrastructure" under MIDH. MD instructed Principal, HTI to organize this workshop in the month of December, 2017.

(Action taken by: Principal, HTI & All MS, DHMIUs)

3.6 Reg. awareness on horticultural technologies, the printing material and audio visuals as a tool of extension needs to be developed. Principal, HTI will prepare pamphlet, brochures, standee, information booklets etc. under the information dissemination through publicity, printing literature etc. component of MIDH and will provide to all MS, DHMIUs for their use in office and forthcoming field functions being organized from time to time.

(Action taken by: Principal, HTI & All MS, DHMIUs)

3.7 It has been observed that some DHCs are not submitting their fortnight progress reports on regular basis. MD instructed all MS, DHMIUs to ensure that the DHCs under their control should submit their fortnight progress report regularly to the office of Mission Director, HSHDA, Panchkula.

# Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2017-18.
